

Table Rock Lake Area Chamber of Commerce 2007 Scholarship Program

Dear Applicant,

This scholarship is a one-time award. Three scholarships will be awarded in 2007. One student from Reeds Spring, one student from Blue Eye and one student from Crane, Galena or Hurley will receive scholarships. Maximum monies will be \$1,000. In the event you are selected to receive this scholarship, monies will be paid directly to the college on your behalf no later than August 1, 2007. It will be your responsibility to notify the TRLA Chamber Education Committee prior to August 1, 2007 by submission of the acceptance letter that will accompany notification of your award.

Eligibility:

1. Applicant permanently resides in Stone County, Missouri and attends Reeds Spring High School, Blue Eye High School, Galena High School, Hurley or Crane High School.
2. Applicant will be a graduate of listed high school's in 2007.
3. Applicant shows evidence of financial need.
4. Application must be completed in full or will not be considered.
5. Return application on or before April 15, 2007. Applications postmarked after that date will not be considered.

Requirements:

- Completed application
- 2 letters of recommendation, one from a school faculty member and one from an outside source such as employer, pastor...
- A copy of your high school transcript
- Write an essay in 200 words or less answering the question: "If this scholarship comes down to a tie between you and one other student, why should we select you?"
